

STN EXPRESS® LICENSE AGREEMENT

The STN Express with *Discover!* software and its documentation in electronic-only form (Software) is licensed to you, Licensee, by the American Chemical Society (ACS), the software supplier for STN InternationalSM, operating through its Chemical Abstracts Service (CAS) division. You may use the Software once you have entered into and executed the STN International Agreement and Order Form. Other individuals within your organization may use the Software provided that you are authorized to enter into the STN International Agreement on behalf of your organization. The Software is available for Windows® and Macintosh®. You may receive the Software via CD-ROM or you may download the Software. You must comply with the following terms and conditions when using the Software:

- 1. Proprietary Information.** Licensee may not modify, decompile or reverse assemble the Software or otherwise attempt to reveal the proprietary programming techniques used in the Software or duplicate, transfer, sell, or in any manner commercially exploit the Software. The Software is proprietary to the ACS and is protected by copyright law and international copyright treaties. The Software cannot be transferred or licensed by you or your organization to a third party. The terms of this Agreement in no way limit ACS' ownership of the Software.
- 2. Single Use License.** Your Single Use License grants you the right to install, on one machine, one copy of Windows or Macintosh Software as purchased. Anyone may use the Software on the machine on which the Software is installed. This Single Use License also grants the primary user the right to make a second copy of the Software for exclusive use on a home or portable computer. This second copy may not be installed on another machine at your workplace for use by others.

- 3. Network/Shared License.** You may install Windows, Macintosh, or both on a Local Area Network (LAN) at one geographic site of your organization or on no more than five (5) machines for each Network/Shared License purchased. This license limits you to no more than five (5) simultaneous users accessing the Software via LAN for Windows, Macintosh, or both for each Network/Shared License purchased. The LAN should have the capability of determining and limiting the number of simultaneous users to ensure compliance with the Network/Shared License provisions of this Agreement. The Software may not be installed for use on a home or portable computer.
- 4. LIMITED WARRANTY.** If your copy of the Software is defective, CAS will replace it free of charge within ninety (90) days from the date of delivery and the sole remedy is replacement of the Software. If your copy of the Software is lost, stolen, damaged, or destroyed, CAS will replace it for a one-time charge of Ten Dollars (\$10.00). EXCEPT AS EXPRESSLY STATED HEREIN, THE SOFTWARE PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EXPRESSED OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, WARRANTIES OF PERFORMANCE OR MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, OR WARRANTIES AS TO THE ACCURACY OR COMPLETENESS OF THE SOFTWARE OR THE DATA ACCESSED USING THE SOFTWARE. IT IS YOUR ENTIRE RISK AS TO THE SELECTION, QUALITY AND PERFORMANCE OF THE SOFTWARE. NEITHER THE STN INTERNATIONAL SERVICE CENTERS NOR ACS AND CAS AND THEIR OFFICERS, DIRECTOR, EMPLOYEES AND AGENTS, NOR ANY OTHER PARTY INVOLVED IN THE CREATION, PRODUCTION OR DELIVERY OF THE SOFTWARE WILL BE LIABLE FOR ANY DAMAGES, LOSSES, COSTS, LIABILITIES, AND EXPENSES THAT RELATE TO THE SOFTWARE OR THAT RESULT FROM YOUR USE OF THE SOFTWARE, INCLUDING, BUT NOT LIMITED TO, LOST TIME, LOST PROFITS, COMPUTER PROBLEMS, OR OTHER SPECIAL INCIDENTAL OR CONSEQUENTIAL DAMAGES, REGARDLESS OF WHETHER SUCH DAMAGES ARE FORESEEABLE OR WHETHER SUCH DAMAGES ARE DEEMED TO RESULT FROM THE FAILURE OR INADEQUACY OF ANY EXCLUSIVE OR OTHER REMEDY. Some jurisdictions may not allow for the exclusion of implied warranties or the exclusion or limitation of liability as specified herein. In this event, it is agreed that the maximum exclusions permitted under applicable law will be deemed to apply.

5. **U.S. Government Restricted Rights.** The Software is provided with RESTRICTED RIGHTS. Use, duplication, or disclosure by the Government is subject to restrictions as set forth in FAR 12.212 (Computer Software).

6. **Effectiveness.** This Agreement becomes effective when you open the CD-ROM or download the Software, and is automatically revoked if you violate any of the terms and conditions contained herein. In that event, or when the License terminates, you are required, at CAS' discretion, to either destroy all copies of the Software or return all copies to CAS immediately. The Software may be updated periodically to ensure its compatibility with STN International online service. This License gives you the same rights to use the updated Software as you have with your current version. To ensure the continued support of your STN Service Center, you must install the updates promptly after you receive them. Use of the Software will be governed solely by the terms of this Agreement even if you submit a purchase order or similar document containing additional terms and conditions when obtaining the Software. If you use a purchase order in conjunction with ordering or paying for the Software, be advised that the terms of the purchase order will in no way modify, add to, or delete any of the terms and conditions of this Agreement. The validity, construction and performance of this Agreement will be governed by and construed in accordance with the laws of the District of Columbia of the United States of America. Licensee is responsible for tariffs, custom charges and duty taxes, value-added taxes, goods and services taxes and sales taxes (if applicable).
